Discussion was held concerning the FY22/23 audit.

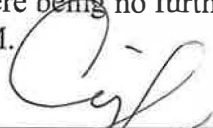
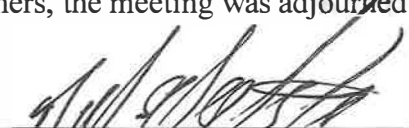
Discussion was held concerning the budget message and submissions changes for the FY24/25 budget.
