Sandra Beeman provided information on the upcoming WACO conference to be held in Rock Springs, WY, September 24-26, 2024.

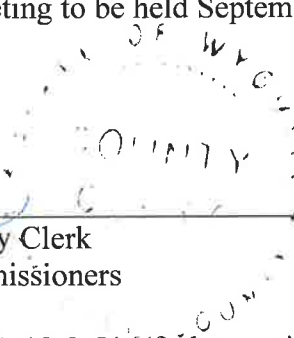
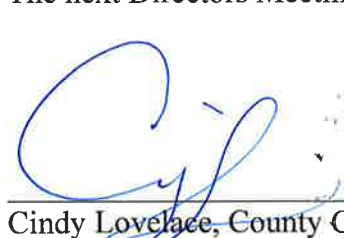
Sandra Beeman provided information on the recognition of David King for his retirement as Emergency Management Coordinator.
