Discussion was held concerning jake brakes being used on Northern Drive.

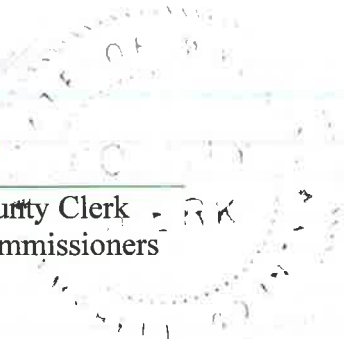
Matt Olsen provided information on the Jocelynn Avenue under Interstate traffic. Discussion was held.

Shelly Edwards requested departments provide her with all changes of Capital Assets.

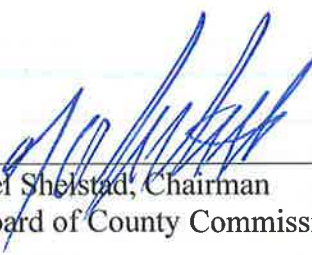
Managers dismissed at 2:14 PM
