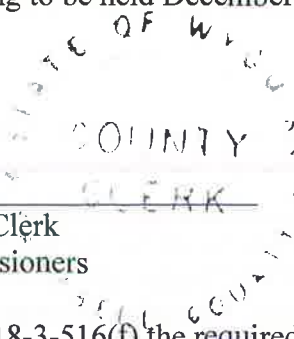
Directors were dismissed at 2:18 PM.
