Directors were dismissed at 3:03 PM

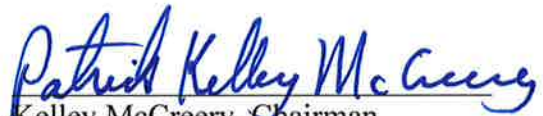
Workshop was held concerning the FY2025-2026 budget process.
