The Board reconvened at 3:35 PM.

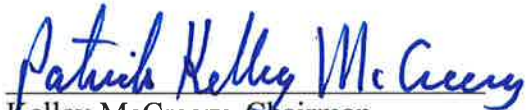
Workshop was held on the Adult Diversion Court Update.
