Sandra Beeman provided information on Wright Days 50th Anniversary Celebration scheduled for June 20-21, 2025. Discussion was held.

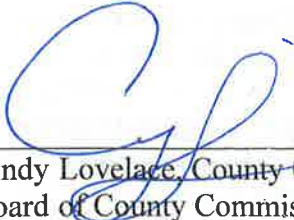
Sandra Beeman provided information on County Board openings. Discussion was held.

Directors were dismissed at 3:00 PM.

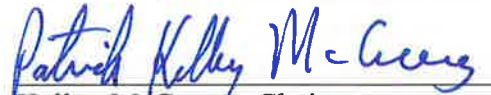
Workshop was held on the PFM Investments Quarterly Report with Joan Evans, Luke Schneider, and Mallory Sampson.
