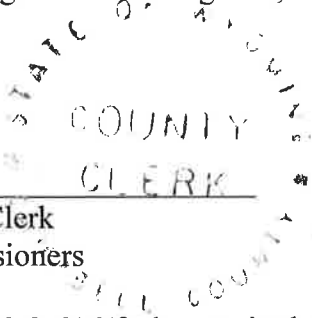
Public Hearing was held concerning the FY2025-2026 budget
