Hi Beth,

I do apologize, but I will not be able to have any reports in today. I hope to have it done in the next day or so. I know we have talked about this a few times in the past year, but I would like to explain why it is so difficult to have these reports in by the 5th of every month.

In order for The CSBG, County, and now the CARES reports to be in and accurate by the 5th of every month, a few things need to be done first.

All invoices for the prior month all need to be entered and coded according the program in which it falls, and the grant by which it is funded. (I don't even receive all invoices in the mail by the 5th, let alone have them all entered.)

Bank Statements need to be reconciled, to be sure there is no mistakes in the checkbooks.

All the invoices for which I am submitting reimbursements for have to be paid.

Every report I am submitting for reimbursement, its required that I send back up, along with any personal info removed. (This takes a lot of time to add all of that to each report.)

If I try to send in all three reports, (or two, once County is used up), there is a very good chance something will be wrong, or not paid, and trying to correct it will be more of a nightmare.

We have prided ourselves on having good and accurate books, passing our audits, and things being turned in on time with no mistakes. We really do not want that to change.

So...do you see the problem we have?... To have everything entered, paid, reconciled, and correct.... and then the backup sent in on top of that, is nearly impossible by the 5th.

I can have everything in and ready to go for all the other grants we have, usually by the 15th, or shortly thereafter, and they are ok with that.

Is there anything we can do? ...If it cannot wait until the 15th or so, is there a reason we can't just be a month behind?

Beth, you have been so helpful in the past trying to get this worked out for us, and we so appreciate it. So if there is anything more you can try for us?.... at this point we don't know what else to do.
