The Board reconvened into their regular meeting at 10:30 AM.

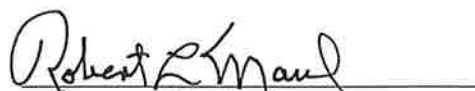
The Commissioners held a workshop on the Pronghorn Industrial Park/Alternatives.
